Definition of Education Supporting Organizations Award

An award that offered to any community organization within or outside the United Arab Emirates: whether it is public, semi-public or private which thrives to serve the educational field and its affiliations, as long as the education is not the main job of the organization.

Incentives and Awards

- The winner is awarded a certificate of appreciation and an excellence trophy.
- A certificate of participation will be awarded to the competing participants.

Participation Requirements

- Initiatives by the applying organization/party must be meant for the service of the educational field in the UAE whether the organization/party is inside or outside the country.
- The organization must be officially recognized.
- Applying organizations must enclose the name and address of one of the beneficiary parties of their initiative(s) in order for the evaluating committees to be able to communicate with them when necessary.
- The organization has the right to participate annually in the award unless it wins.
- If the organization won the award, it can participate in the award again after 2 cycles with new initiatives.

Definitions

Applying Organization/Party

Any officially recognized organization by expert parties – whether official, semi-official or private, inside or outside the country – on the condition that its activities and initiative(s) are meant to serve education in the UAE. Education should not be the organization's business core or the initiative(s) should not represent the organization business core.

Educational Field

All parties related to or benefiting from education in the UAE and represented by the Ministry of Education or affiliated to it, be it teachers, students or any relating curricula and educational service either in public or private schools, as well as universities or any educational institution.

Initiative(s)

Services provided by the applying organization/party to the educational field or its members, i.e. creating and developing curricula, teaching methods and supports – scholarships – training programs – funding studies and research – funding applied educational projects – nurturing the gifted and advanced students – promoting distinguished students – building educational facilities as classes, labs, etc. Competing organizations can apply for a single or several initiatives, knowing that what is valued is the quality of the initiative, its continuity and the number of its beneficiaries.

Tangible Positive Impact

The outcomes obtained as a result to the execution of the initiative(s) either in the educational field or in the applying organization/party.

Important Instructions

1. Follow the attached participation form and be sure to use Arial font with 12 size.
2. Participation in the award must be in the name of applying organization/party.
3. The organization that would like to participate should fill the nomination form electronically.
4. Provide a brief summary about the initiative including the definition of the initiative, expected outcomes and tangible Positive Impact, with a maximum of 1000 word.
5. Avoid pasting or attaching any additional pages in the nomination form.
6. The organization will provide a presentation about the initiative that will not exceed an hour.
7. Notice that the team members should not be more than 10
